### **The Berry Forum**

Our client has requested that we write to you following his attendance at the Berry Forum (**Forum**) meeting held on Thursday, 15 February 2018 (**Meeting**).

During the course of the Meeting, our client formed the view that his recent Requests for Information from the Forum (**Requests for Information**), and his intentions generally, may have been misinterpreted by the Forum Committee (**Committee**).

Our client was surprised to see that the Requests for Information were recorded under the title of "*Complaints about Forum Committee*" in both the Meeting Agenda and on the Berry Forum Website (**Forum Website**).

When the subject of our correspondence to the Forum was presented under the same title at the Meeting, our client felt that this portrayed the Requests for Information in an unjustifiably negative light.

Given the response from the floor at the Meeting, our client did not wish to unnecessarily inflame the situation by speaking out at the time but felt that it would be more appropriate to address the matter by writing to the Forum.

To provide further context to the Requests for Information, and our client's Submission to Shoalhaven City Council (**Council**), our client would like to make the following clear:

- 1 Our client has not made any complaint about the Forum or the Committee;
- 2 As noted in our letter dated 24 January 2018, our clients' submission to Council is not about the Forum's activities specifically, but rather provides commentary on the Guidelines that govern all Community Consultative Bodies (CCB) in the region;
- 3 Our client began his review of the Forum Website, and subsequently made the Requests for Information, to assist with the preparation of his submission to Council; and
- 4 If our client has any specific concerns about any activities of the Forum, he will of course make comment to the Committee directly, as was done previously in our letter dated 24 January 2018.
